**WHEREAS** this work is very typical and expensive nature. Therefore, financial provision needs to be made for this work. Hence an Administrative / Processing fee should be charged to per proposal/ per case as mentioned in the following table.

**WHEREAS** the car fare, first class with A.C. Railway fare and air fare will be permissible as per special approval of the Hon'ble Vice Chancellor.

**WHEREAS** the camp of CAS arranged at college level the expenditure of TA/DA be borne by the concerned college/ Trust.

**WHEREAS** Expenditure on Tea/ Refreshment and Material used for prevention of COVID-19 may be adjust against the total amount of processing fee.

**WHEREAS** in the present situation there is no single line for the function of the camp of CAS and process the applications received from the eligible Teachers to Promote as per successive level 11, 12, 13A and 14.

**AND**

**WHEREAS** the said regulation has not placed before any authorities/ bodies for consideration.

**AND**

**WHEREAS** the Academic Council & Management Council are not likely to meet at present and need of the regulation is required to implement for process the working of the camp held at Osmanabad, Beed, Jalna & Aurangabad.
